The Pumpkin Patch Committee reserves the right to object to anything on display that it feels falls into this category. If you display anything the Committee finds objectionable you will be asked to remove such items. Failure to comply will result in you being asked to leave with no refund. **You may not sell bottled water or sodas as that competes with MLUMC fundraising efforts.** By signing this application you agree to these stipulations.

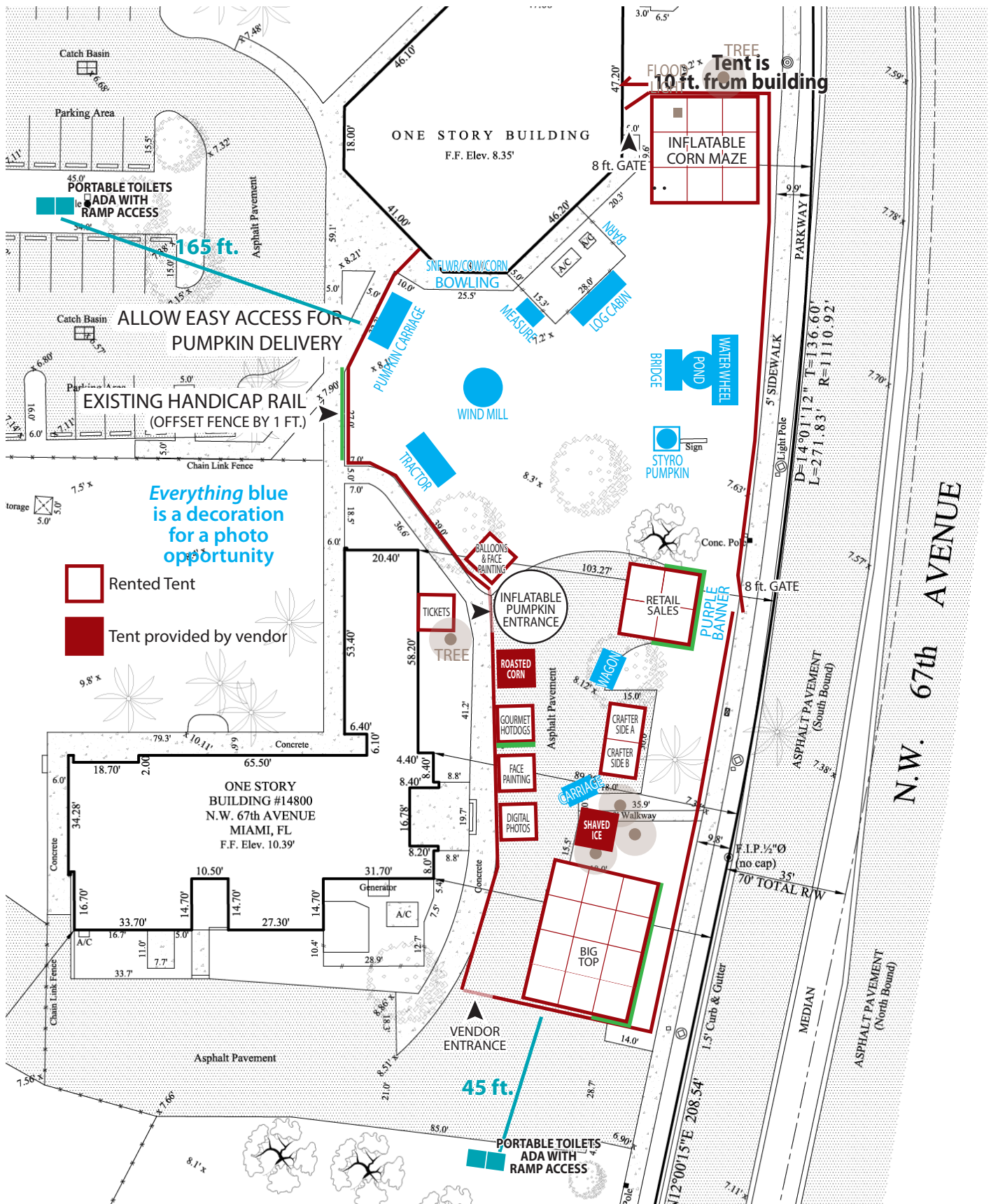
